- In pursuance of sub-section (a) of section 38 of the Insurance Business Law, this licence is granted to the under mentioned company on the day of 28 November 2019 at Nay Pyi Taw.

CONDITIONS

The Licensee and its parent company ("Parent Company") must agree to and comply with the following conditions:

- i. the Licensee shall only write life insurance business policies.
- ii. the Licensee shall not, without the approval of the Ministry of Planning and Finance ("Ministry"), do any of the following:
 - (a) provide any guarantees relating to loan transactions; and
 - (b) sell any types of insurance product that insure risks which have not been previously written in Myanmar within the life insurance business market.
- iii. the Licensee shall maintain a high level of management and insurance expertise by providing adequate training and development to its staff.
- iv. the Licensee shall immediately inform the Ministry if:
 - (a) it is or is likely to be unable to meet the regulations and its obligations under the Insurance Business Law, Insurance Business Rules, and any other orders and directives issued by the Ministry and the Insurance Business Regulatory Board ("IBRB") from time to time;
 - (b) it becomes aware of any material event i.e. an event that has significant impact on the Parent Company and/or the Licensee, including any breach of regulations imposed by the Ministry, the Myanmar Government or by other authorities in Myanmar or elsewhere;
 - (c) any of its directors, key executive persons or executive officers is involved or believed to be involved in any unethical conduct or practices in conflict with interests of the Licensee or its policy owners/cedants;
 - (d) it participates in any pool business other than pools formed by the Myanmar insurance industry to cover special risks;
 - (e) there are significant corporate, financial or holding structure changes in the Parent Company and in the operations of the Licensee; or
 - (f) there is a change in the substantial shareholders (i.e. holders of at least 10% of the total issued share capital) of the Parent Company and/or the Licensee or there is a change in any individual or corporate entity who has effective control¹ of the Parent Company.

¹ An individual or corporate entity will be considered to have effective control over another entity if it:-

⁽a) controls the composition of the board of the latter-mentioned corporate entity; or

⁽b) is in a position to exercise, or control the exercise of, more than one-half the maximum number of votes that can be exercised at a meeting of the latter-mentioned corporate entity.

- v. The Licensee shall comply with the Insurance Business Law, the Insurance Business Rules, and any directives or notifications issued by the Ministry or the Myanmar Government.
- vi. The Licensee is expected to implement all necessary policies and procedures to manage Anti-Money Laundering/ Combating the Financing the Terrorism ("AML/CFT") risks.
- vii. The Parent Company shall inject capital into the Licensee in accordance with the amounts and timeline committed in its proposal ("Proposal") submitted under the Request for Proposal ("RFP") dated 18th January 2019.
- viii. The Licensee shall ensure that the total staff headcount (including percentage of local Myanmar staff employed) is in accordance with the Proposal.
- ix. The Licensee shall ensure that the written approval of the Ministry is obtained before the appointment of, or subsequent change in appointment of, any of the following key executive persons (or its equivalent):
 - (a) Chief Executive Officer
 - (b) Chief Financial Officer
 - (c) Chief Risk Officer
 - (d) Certifying Actuary
- x. The Licensee shall comply with the directions of the Ministry in relation to key executive persons that do not fully satisfy the qualifications required by the Ministry.
- xi. The Licensee shall appoint a Chief Executive officer on a full-time basis, based in Myanmar, from the issuance of the licence to manage the life insurance business in Myanmar.
- xii. The Licensee shall pay the prescribed annual fees for the business licence.
- xiii. The Licensee shall return its business licence to the Insurance Business Regulatory Board when its insurance operations are discontinued.
- xiv. The Licensee shall not transfer its business licence to another person.
- xv. The Licensee shall commence its operations immediately from the date on which the licence is granted.
